# HERITAGE PARK

## Terms and Conditions

Valid for the 2025 - 2026 Season

1. Purchase of your Annual Membership constitutes acceptance of the Heritage Park Annual Membership terms and conditions. Heritage Park reserves the right to change member holder benefits, prices, terms and conditions without notice. Current benefits, prices, terms and conditions are available to read at [heritagepark.ca](http://heritagepark.ca).
2. All Annual Memberships are non-refundable, non-transferable, may not be re-sold and may only be used by the person named on the card. The only exception is the Transferable Guest Membership, which is transferable and can be used by any one individual who is accompanied by a current member.
3. A replacement fee may be charged for lost or stolen membership cards.
4. Each membership holder must only be in possession of ONE Annual Membership card.
5. All Annual Memberships are valid for 365 days from the date of purchase or renewal. Please allow 3 days for Guest Services to process, activate and print your physical membership card. If you'd like to visit before your card is ready, simply present a copy of your purchase or renewal receipt to gain entrance to the Park and to access your member benefits. In the case of early renewal, existing memberships will be renewed for another 365 days from the current expiry date.
6. Annual Membership card(s) must be presented at the gate to gain entry into Heritage Park Historical Village and Gasoline Alley Museum. In the event of a forgotten card, Heritage Park reserves the right to request picture identification before entry is granted. Photocopies, photographs, or digital copies of memberships are not valid for entry.
7. Transferable Guest Memberships must be used in conjunction with an existing Annual Membership, and are only valid when the member linked to the guest membership is present. A Companion Membership holder can add a Transferable Guest Membership, but it will only apply to the individual Companion Member who purchases it. If both Companion Members want to add a Transferable Guest Membership, each must purchase one separately.
8. Members must present a valid membership card to redeem associated benefits. Only one membership card may be applied per transaction and benefits/discounts cannot be combined.
9. Members receive unlimited, year-round entry to Gasoline Alley Museum and unlimited entry to Heritage Park Historical Village during regular operating hours, complimentary entry to certain special ticketed events like Once Upon A Christmas, a 15% discount at all retail locations (*some restrictions apply*) and a 15% discount at all food & beverage venues (*some restrictions apply*).
10. Members receive a 15% discount on select Heritage Park special ticketed events. To apply the discount, members must book through Guest Services by phone. For online ticket sales through Showpass, members need to contact Guest Services to verify their membership and receive a discount code. Members may not share, distribute, or sell exclusive member-only discount codes to non-members. However, members can apply their discounts to non-member meals, shopping, or special event tickets, as long as the member is the one completing the purchase.
11. Visitors can apply the cost of their day gate admission (*excluding GST*) toward an Annual Membership within 7 days of their visit by presenting their receipt. Up to 2x adult or senior day admissions can be applied to a Companion Membership. For Family & Friends Memberships, more than two day admissions can be used. All other membership upgrades require a one-to-one match with the admission type.
12. Gift or promotional Annual Membership vouchers are only valid for Annual Memberships, have no cash value and cannot be used for other purchases.
13. Annual Memberships do *not* include complimentary admission to select special ticketed events, such as Day Out With Thomas & Ghoul's Night Out.
14. Visitors under the age of 14 must be accompanied by an adult at all times to enter the Park.
15. For a Family & Friends Membership, if not all members are present at the time of pick-up, they can be added later, up until the membership's expiry date.
16. All Heritage Park Annual Membership Cards remain the property of Heritage Park at all times. The Park reserves the right to confiscate cards in cases of intentional misuse, if a card is used by a non-member, or in the event of any misconduct. No refunds will be issued.
17. Heritage Park reserves the right to close or remove any exhibit or attraction at any time due to special events, routine maintenance, weather, or other factors. No refunds, credits, or extensions will be provided for Annual Memberships as a result of these situations.
18. Annual Memberships can be applied to certain educational programs, including the Living History Self-Guided School Program and Summer Camps. Memberships do not apply to course-based school programs that involve staff teaching time or PD Day Camps.
19. Annual Members are responsible for setting up and activating their own ParkPlus account. Once the account is set up with the membership code, information, and license plate, parking is complimentary for each visit during the membership's validity, provided the membership is in good standing. Heritage Park is not liable for any tickets or penalties incurred if the member fails to register or incorrectly registers their ParkPlus account.
20. Guests of Annual Members receive 25% off the regular day admission fee when accompanied by the member.
21. By entering Heritage Park, you consent to being photographed, filmed, or videotaped during your visit for promotional purposes. You also relinquish any rights to take legal action against Heritage Park for the use of these images and videos in marketing materials.
22. You voluntarily assume full responsibility for any risk of personal injury, property damage, or death that may arise from your participation in activities or your presence on the premises. This assumption of risk applies to both known and unknown risks, even those arising from the negligence of Heritage Park or its affiliates.
23. By participating, you hereby waive, release, and discharge Heritage Park, its directors, employees, agents, volunteers, and affiliated organizations ("Released Parties") from any and all liability, claims, demands, or causes of action resulting from any injury, loss, or damage, regardless of whether caused in whole or in part by the negligence of the Released Parties.
24. By participating in activities or being present on the property, you acknowledge and accept the inherent risks and hazards that may be involved, including but not limited to: Uneven Surfaces: Risks associated with gravel, dirt, rocks, and other natural or man-made terrain that may cause slips, trips, or falls. Animals: Risks related to the presence and behavior of both wild and domesticated animals, which may include bites, scratches, or other injuries. Vehicular Traffic: Risks from cars, trucks, or other vehicles on or near the premises that could lead to accidents or collisions. Environmental Hazards: Weather-related conditions such as rain, wind, heat, or cold that may impact safety. Personal Safety: Risks related to failure to act within one's abilities, stay within designated areas, or exercise caution. First Aid: Risks associated with the administration of first aid or medical assistance. Infectious Diseases: Risks of contracting viruses, bacteria, parasites, or fungi through direct or indirect contact. Outdoor/Recreational Risks: Risks related to equipment failure, negligence by other participants, or unforeseen circumstances. Negligence: Potential negligence by Heritage Park, its directors, employees, volunteers, independent contractors, agents, or any associated parties.

Our systems and procedures are designed to prevent loss, misuse, unauthorized access, disclosure or alteration of personal information. Only authorized Heritage Park Staff have access to your personal information of which will only be used if needed for Membership purposes.
